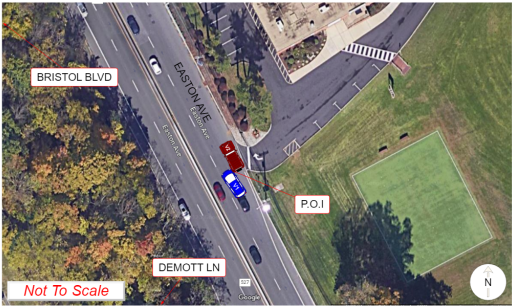

145. Crash Description/Narrative

V1 and V2 were both traveling north bound on Easton Ave

V2 was slowly merging into the upcoming entrance lane for the Rutgers Preparatory School when V1 attempted to pass V2 on the left side.

V1's front passenger fender collided with the rear driver side corner of V2's vehicle causing damage to both vehicles.

V1 continued driving north bound on Easton Ave. after colliding with V2, leaving the scene.

Based on the on-scene investigation and assessment of the damage to the vehicles, V1 improperly passed V2 causing a motor vehicle crash.
