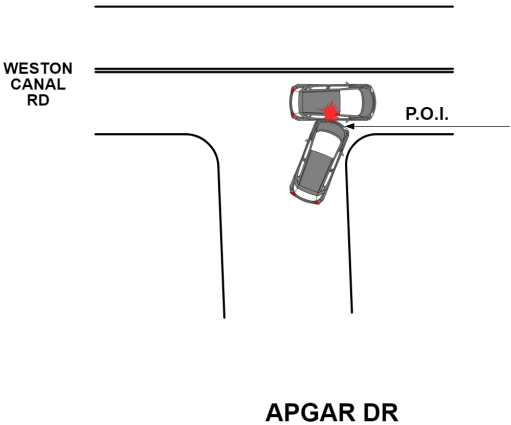

V1 WAS FACING NORTH ATTEMPTING TO MAKE A RIGHT TURN ONTO WESTON CANAL ROAD. V2 WAS TRAVELING EAST ON WESTON CANAL ROAD.

D1 STATED THAT HE BELIEVED HE HAD ENOUGH TIME TO COMPLETE HIS RIGHT TURN BUT V1 WAS TRAVELING AT A HIGH SPEED AND HIT HIM ON THE FRONT END OF HIS VEHICLE.

D2 STATED THAT HE WAS TRAVELING EAST ON WESTON CANAL ROAD AND WAS HIT ON HIS PASSENGER SIDE DOOR. HE STATED THAT HE BELIEVED THAT V1 SAW HIM.

DURING MY TRAFFIC INVESTIGATION, I DETERMINED THAT V1 WAS THE CAUSE OF THE CRASH DUE TO HIS FAILURE TO YEILD THE RIGHT AWAY VEHICLE. IT SHOULD BE NOTED THAT V2 PULLED INTO PRIVATE PROPERTY AND RESTORED HIS DRIVERS INSURANCE AFTER THE CRASH.

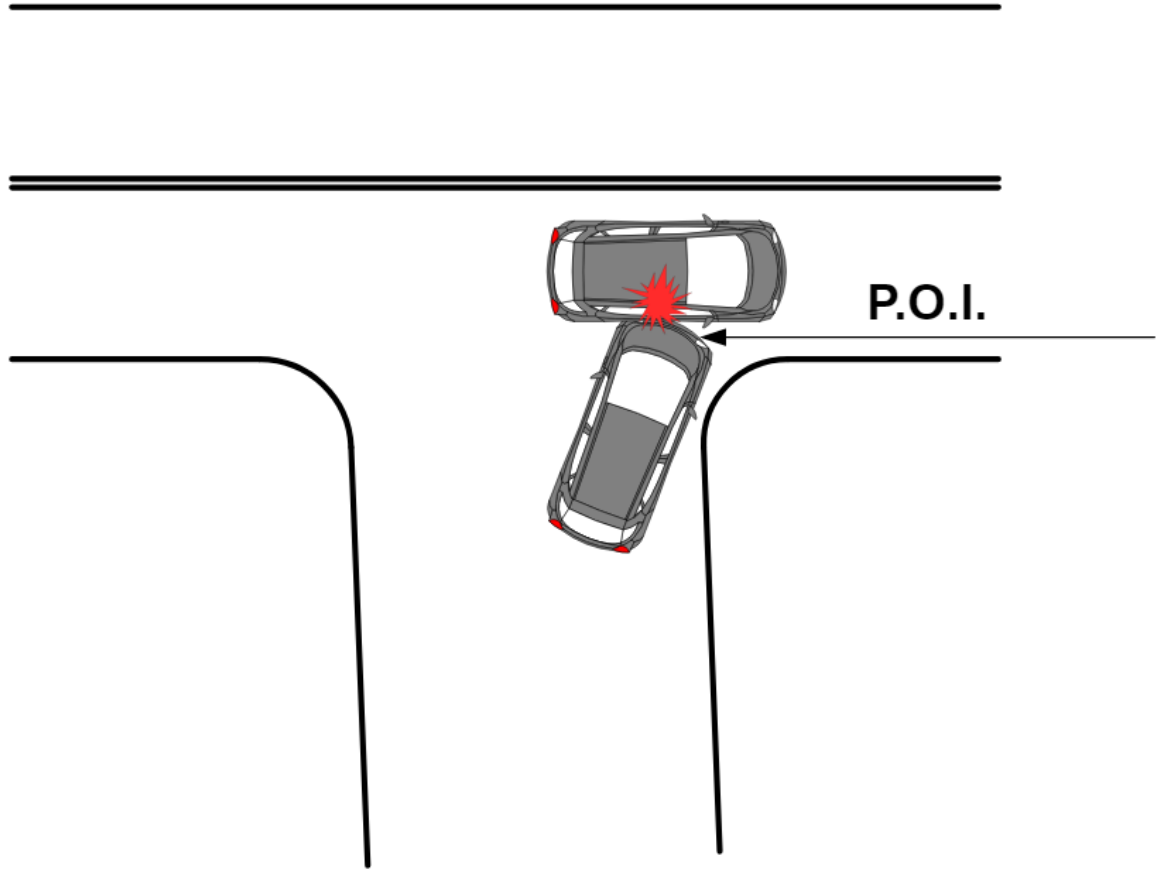
