145. Crash Description/Narrative

V1 was traveling North on Easton avenue and in the area of Girard Avenue, attempting to change lanes into the inner lane of travel. In doing so, V1 struck V2's rear trailer causing minor damage.

V2 was traveling North in Easton avenue in the far lane of travel near Girard Avenue. V2 felt something strike his rear trailer while traveling north and it was V1 attempting to merge lanes.

V1 caused the collision with V2 due to an improper lane change.
