Vehicle 01 was parked in the rear parking lot of 585 Somerset St. Vehicle 02 backed up in the parking lot and struck vehicle 01. Driver 01 stated that as she was in her vehicle and noticed vehicle 02 backing. Driver 01 stated that she attempted to alert the driver of vehicle 02 by honking her horn but vehicle 02 continued to back up and crashed into her car. Driver 02 stated that he thought it was clear to back up. Driver 02 also stated that he was looking at the passenger side rear view mirror as he was backing and did not notice that vehicle 01 was behind him. The investigation revealed that driver 02 backed unsafely.
