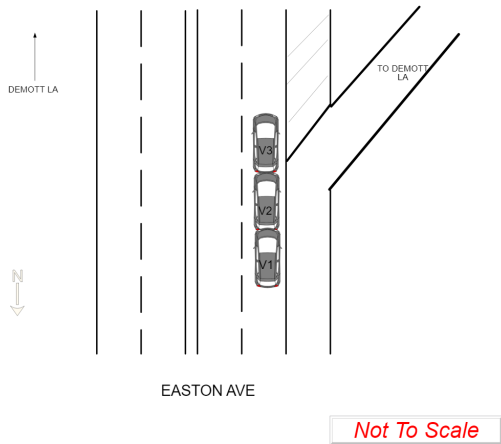

145. Crash Description/Narrative

V1 struck V2 and V2 struck V3

D1 advised he was travelling south- bound on Easton Ave when he attempted to stop at a red light. D1 advised his brakes did not work and V1 struck V2. D1 advised his tires were bald and brakes did not work. D1 advised he did not need medical attention.

D2 advised he was stopped at a red light on the south-bound side of Easton Ave. D2 advised V2 was struck by V1. D2 advised he was set in motion by V1 and subsequently V2 struck V3. D2 advised he had no injuries and did not need medical attention.

D3 advised she was stopped at a red light on the south-bound side of Easton Ave. D3 advised V2 struck V3. D3 advised her child complained of a head injury. RWJ BLS arrived on scene and advised to monitor the child. D3 advised she did not need medical attention.

I tested the brakes of V1 and found them functioning properly.

D1 caused the crash by not driving safely in wet conditions.
