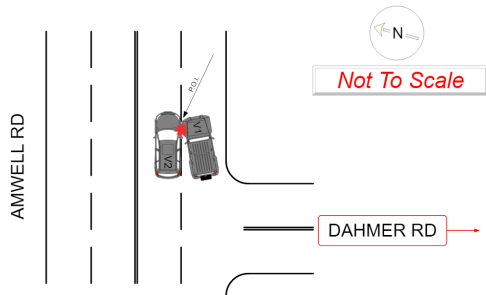

V1 SIDESWIPE V2.

D1 STATED V1 MISSED A RIGHT-TURN, IN WHICH V1 THEN ATTEMPTED TO MAKE A LEFT-TURN FROM THE RIGHT LANE, WHICH RESULTED IN V1 COLLIDING INTO V2.

D2 STATED V2 WAS TRAVELING STRAIGHT WHEN V1 SUDDENLY STRUCK V2.

BASED ON THE STATEMENTS GIVEN AND MY OBSERVATIONS, D1 CAUSED THE MVA DUE TO DRIVER INATTENTION.
