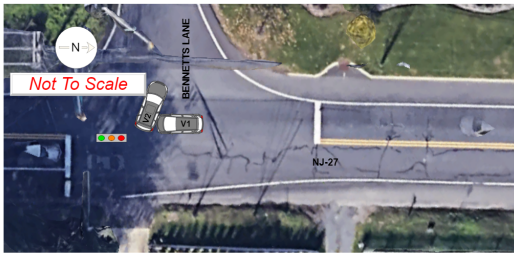

145. Crash Description/Narrative

D1 STATED HE WAS DRIVING SOUTH BOUND ON NJ-27 WHEN V2 SUDDENLY MADE A LEFT TURN IN FRONT OF HIS VEHICLE CAUSING THEM TO COLLIDE. D1 STATED A WITNESS WAS THERE AND LEFT HIS CONTACT INFORMATION WHICH HE PROVIDED TO ME.

D2 STATED HE WAS TRAVELING NORTH BOUND ON NJ-27. WHEN HE REACHED BENNETTS LANE, HE PROCEEDED TO MAKE A LEFT TURN ONTO BENNETTS LANE. WHEN HE MADE HIS LEFT TURN, HE WAS STRUCK BY V1. D2 STATES HE EXECUTED HIS LEFT TURN WHEN THE GREEN LEFT TURN ARROW APPEARED ON THE TRAFFIC SIGNAL.

I SPOKE WITH THE WITNESS CHINUA MCDONALD (973-885-8700) WHO STATED HE WAS STOPPED AT THE RED TRAFFIC SIGNAL ON BENNETTS LANE. HE STATED HE OBSERVED V1 HAVE THE GREEN LIGHT AND AS HE DROVE FORWARD, V2 SUDDENLY TURNED IN FRONT CAUSING THE VEHICLES TO COLLIDE.

BASED ON MY INVESTIGATION, V2 FAILED TO YIELD THE RIGHT OF WAY TO V1.
