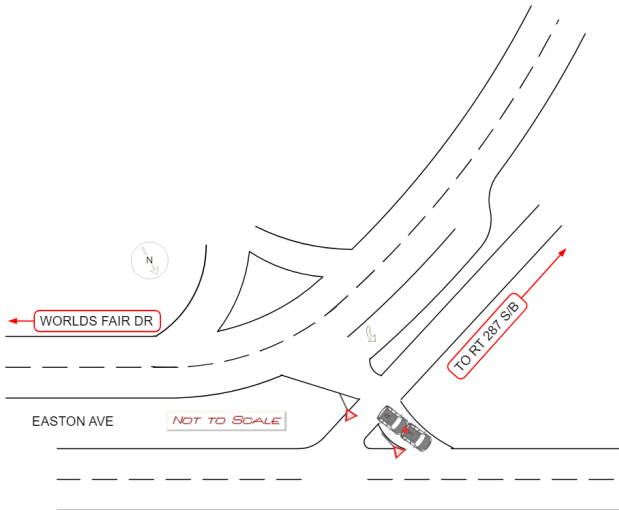

V1 WAS TRAVELING ON NORTH ON EASTON AVENUE AND V2 WAS STOPPED AT THE YEILD SIGN ON EASTON AVENUE FACING NORTH.

D1 STATED AS HE WAS TRAVELING ON EASTON AVENUE HE STOPPED AND OBSERVE V2 IN FRONT OF HIM AT THE YIELD SIGN. D1 RELAYED WHEN HE LOOKED AWAY AND TURN BACK AROUND, HE DID NOT OBSERVE V2 IN FRONT OF HIM AND PRESSED ON THE GAS PEDAL. V1 STATED AT THIS TIME, HE CRASHED INTO THE REAR BUMPER OF V2. V1 STATED HE DID NOT OBSERVE V2 IN FRONT OF HIM PRIOR TO THE CRASH.

D2 STATED WHILE SHE WAS STOPPED AT THE YEILD SIGN WAITING TO GO, V1 CRASHED INTO THE REAR OF HER VEHICLE. V2 STATED SHE WAS STOPPED AT THE TIME OF THE CRASH.

WHILE ON THIS MOTOR VEHICLE INVESTIGATION, I DETERMINED THAT V1 CAUSED THIS CRASH BY FOLLOWING TO CLOSELY AND DRIVER INATTENTION. D1 SHOULD HAVE MADE SURE THAT V1 WAS NOT IN FROM OF HIM PRIOR TO PRESSING ON THE ACCELERATOR AND ALSO KEPT A GOOD DISTANCE BETWEEN HIS VEHICLE AND V2.
