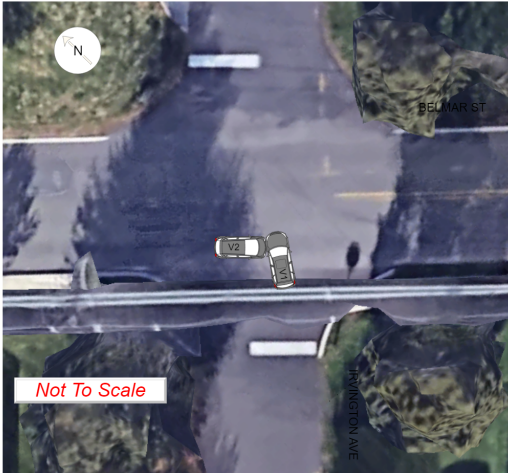

D1 related she had stopped at the stop sign for Irvington Ave. and Belmar St. D1 related she attempted to turn left and V2 came speeding down Belmar St. and struck her.

D2 related he was travelling straight on Belmar St. when V2 pulled out in front of him prior to him striking her.

I observed damage to the front drivers side of V1. I observed front end damage to V2. Investigation revealed V1 failed to allow the right of way to V2 who was travelling straight and this led to the crash.
