145. Crash Description/Narrative																		
Invest: V2 parked along Hamilton St. V1 traveling east bound on Hamilton St. V2 opened door and was struck by V1. Owner of V2 stated the following: after parking and attempting to exit his vehicle, he opened the driver side door which was struck by a passing vehicle. D1 stated the following; while traveling on Hamilton St, V2 opened its door just as she was passing. While on scene, I was able to locate video footage of the accident from 507 Hamilton St (Imperial Super Market), on the video, you can see V2 arrive and park the vehicle, it should be noted, V2 was not parked in a marked parking space along Hamilton St. Shortly after parking, the driver door opens and is subsequently struck by V1 while passing. Investigation revealed D1 struck V2 due to V2 opening the door without making sure the area was clear.
