D1 REPORTED WHILE APPROACHING THE BRIDGE ON CANALRD, HE DID NOT OBSERVE HOW CLOSE HE WAS TO V2. WHILE ATTEMPTING TO CONTINUE TO GO AROUND V2, HE SIDE SWIPED IT.

D2 REPORTED WHILE SHE WAS DRIVING OVER THE BRIDGE, V1 WAS ATTEMPTING TO GO AROUND HER AND SIDESWIPE THE BUS.

INVEST REVEAL V2 WAS SIDESWIPE BY V1 WHILE V1 WAS APPROACHING THE BRIDGE.
