145. Crash Description/Narrative

Invest: Both vehicles were traveling south on Somerset St. V2 was stopped in traffic, V1 failed to observe same subsequently rear ending V2.

D1 stated the following; while driving on Somerset St. he did not notice or realize V2 was stopped in traffic. When he did, it was too late and unable to avoid the accident. D1 stated the accident was his fault.

D2 stated the following: she was stopped in traffic and out of nowhere felt the impact from behind.

Investigation revealed D1 caused crash due to driver inattention. D1 was issued a summons for careless driving pending a court date.
