Narrative				
On Tuesday, May 21, 2024, I observed a moped at the intersection of Anderson Avenue and Lafayette Avenue bearing New Jersey registration [REDACTED]. I then entered the vehicle registration into the infocop system and the registration returned not on file. The vehicle then made a left turn onto Lafayette Avenue. I then began to follow then vehicle which then made a left turn into the parking lot of [REDACTED] Lafayette Avenue. At this time I then activated the emergency lights in CP-5 and began to initiate a motor vehicle stop. The vehicle came to a stop and then began to go in reverse towards my vehicle. I exited my vehicle and advised the driver to stop and pull forward. The driver then began to pull forward and I then advised the driver to stop where he was. The driver then took off through the parking lot and proceeded north on Railroad Avenue. The vehicle then made a right turn onto Wayne Avenue. At this time I notified Police Headquarters that I attempted to conduct a motor vehicle stop and the vehicle took off. I further provided police headquarters a description of the driver and the moped along with a direction of travel. I advised police headquarters that I was not in pursuit of the vehicle as well. A short time later I was advised by police headquarters that the moped was currently in the area of [REDACTED] Wayne Avenue. At this time Officer Perez, Officer Kong and I then proceeded to the area. Upon our arrival we observed the moped and the male on the sidewalk in the area of [REDACTED] Wayne Avenue. Officer Perez exited his vehicle and advised the male to stop at which time the male then attempted to flee. See Officer Perez's arrest report
