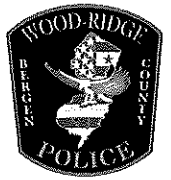

On Friday 04/04/2025 at approximately 1645 hours I was monitoring the radio when I heard an East Rutherford Officers was behind a stolen felony vehicle, MA registration 2JFX66 on blue Mercedes Benz, traveling north on Mount Pleasant in Wallington. The vehicle was wanted out of Union Township and was entered into NCIC as a felony vehicle. I began to respond to the area.

While responding I heard that the vehicle made a left turn and was heading west bound towards South Main St. I continued to respond to the area when I heard that Wallington Officers were also with the East Rutherford Officer and the vehicle turned onto Crescent Rd. which is a dead end street. Officers attempted to stop the vehicle but it rammed a Wallington Officer and fled back towards South Main St.

At that time I observed the vehicle make a right turn onto South Main St. and began to travel north. I engaged the vehicle which failed to yield. The vehicle continued on South Main St. and then made a right onto Passaic St. As the vehicle entered Hasbrouck Heights I deactivated my lights and siren and terminated the pursuit due to public safety. I observed the vehicle travel the wrong way on the traffic circle then north on the Boulevard and east on Henry St. No further action.

At the above date and time I was in the parking lot of the Element Hotel on Route 17 South when I observed a dirt bike style motorcycle with no registration traveling on Route 17 South bound at high rate of speed.

I pulled behind the motorcycle and activated my lights and siren. I observed the motorcycle to be occupied by a male party dressed all in black, wearing ski mask. I began to follow the motorcycle with my lights and siren activated. The driver looked back at me and began to pull over to the shoulder. He looked back at me again and then continued on Route 17 south towards Union Ave. Headquarters was notified. While approaching Union Ave. I advised headquarters that I would be terminating pursuit. The driver then made a right turn onto Union Ave. at the red traffic signal. At that time I was behind two vehicles who failed to yield. Once I made the right turn onto Union Ave. I no longer had sight of the motorcycle and turned off my lights and siren.

Upon reviewing video I observed that once the driver made a right onto Union Ave. he then made a U-turn and turned back onto Route 17 South. A use of force report was completed and a pursuit was generated in Guardian Tracking.

At the above date and time I was searching the town for a hit and run vehicle described as a white Toyota Tacoma with large tires for a motor vehicle crash that occurred in Wood-Ridge when I heard Lyndhurst Police transmit over SPEN that a white Toyota Tacoma bearing T99UAF fled from a motor vehicle stop heading towards Route 17.

I responded to Route 17 North via Rt. 120 and observed the white Toyota Tacoma being followed by two Lyndhurst Police vehicles that were not in pursuit. A Lyndhurst Police Officer, later identified as Lt. Haggerty, pulled along side the vehicle to observe the driver.

The two Lyndhurst Officers and myself then activated our emergency lights and siren in an attempt to stop the vehicle. The vehicle refused to pull over. As we entered Wood-Ridge I became the lead vehicle. The suspect vehicle then began to accelerate at a high rate of speed traveling approximately 86 mph. At that time I terminated pursuit as we passed Moonachie Ave. I observed the vehicle to continue to travel on Route 17 north making unsafe lane changes, driving on the shoulder and failing to observe traffic signals. Towns north on Route 17 and the Montvale Police Department were notified on SPEN.

I returned to headquarters and contact the Lyndhurst Police Department. I was advised that Lt. Haggerty positively identified the driver as the registered owner. A pursuit report was completed in the AG portal and a pursuit was created in Guardian Tracking.

Summons were issued for leaving the scene, failure to report, improper passing over double yellow, speeding, careless driving, reckless driving, unsafe lane change, failure to signal, tailgating, improper passing on shoulder, failure to observe traffic signal, failure to pull over for emergency vehicle and failure to keep right at intersection

On August 15, 2024, P.O. R. Cangialosi #128 and I, P.O. M. Roncaioli #133 were assigned as uniformed patrol and were operating a marked radio car equipped with lights and sirens. While on patrol monitoring Statewide Police Emergency Network (SPEN) Maywood Police Department transmitted over SPEN at approximately 0822 hours a Acura White in color bearing (NJ Reg: Z94HWR) was stolen out of their jurisdiction today (08/15/2024) and possibly traveling southbound on Route 17. Continuing listening to SPEN, Maywood Police transmitted further information informing surrounding agencies the actor operating the above mentioned vehicle is described as a heavy set, white male, with tattoos wearing a baseball cap and was now possibly traveling on "Route 46" towards Little Ferry (Reference Maywood Police Case Number # 2024-006849)

After receiving this we made our way to the intersection of Industrial Ave. and Route 46 Teterboro, NJ in attempt to locate the vehicle but were met with negative results. Upon approaching the intersection of Route 46 West and Industrial Ave. we observed an Acura SUV white in color, matching the description that was broadcasted on SPEN by Maywood Police. Keeping visual on the vehicle we observed the operator of the vehicle, later identified as the actor, Mr. Daniel Mactaggart, who matched the above mentioned description that was transmitted over SPEN. At this time we then were able to observe the vehicles registration (NJ Reg: Z94HWR) which allowed us to confirm it was the vehicle in question. We then transmitted over the Wood-Ridge Police radio channel informing dispatch we located the stolen vehicle on Industrial Ave.

While trailing the vehicle waiting for surrounding police agencies to get within closer proximity the above mentioned vehicle began to accelerate at a high rate of speed. Mr. Mactaggart then crossed over the double yellow lines going against traffic into the northbound lane. Mr. Mactaggart then swerved past several vehicles awaiting the traffic signal at the intersection of Industrial Ave. and Teterboro Landing Dr. At this time we attempted to initiate a motor vehicle stop activating our lights and sirens on Industrial Ave. near the parking lot of Walmart. Mr. Mactaggart disregarded our emergency lights and continued to travel northbound on Industrial Ave. We continued to pursue the vehicle while Mr. Mactaggart committed multiple motor vehicle violations. At this time we then notified dispatch of our travel location in attempt to provide a better to location to police agencies that were responding. While pursuing the vehicle it made a left turn off of Industrial Ave. in attempt to enter the parking lot of 233 Industrial Ave. Teterboro, NJ 07608 (Atlantic Aviation) but was unsuccessful due to the parking lot gate blocking the vehicles entry. At this time, we positioned our radio car behind the above mentioned vehicle blocking the suspect vehicle in. We then exited our radio car with our weapons drawn, pointed at the actor, Mr. Mactaggart.

While having our weapons drawn giving verbal commands to Mr. Mactaggart to exit the vehicle, Lt. Rutigliano and multiple surrounding police agencies consisting of Moonachie, Hasbrouck Heights, Maywood, and Little Ferry responded to our location. I gave multiple verbal commands to Mr. Mactaggart to exit his vehicle and show me his hands which he was non compliant. Mr. Mactaggart continued to keep his hands out of our view and repeatedly told us he is unable to show us his hands. Attempting to de-escalate the situation by attempting to build a rapport with Mr. Mactaggart, he told us he needed to take a plane to Dallas to watch the Dallas Cowboys. While still speaking with Mr. Mactaggart I continuously told him to show us his hands. Still with our weapons drawn and pointed at Mr. Mactaggart, he exited the vehicle and began to walk into the parking lot of Atlantic Aviation away from us.

Once this occurred we re-holstered our weapons and pursed Mr. Mactaggart on foot. We then tackled Mr. Mactaggart from behind, brought him to the floor, and apprehended him with the assistance of other officers from the surrounding agencies that responded.

Mr. Mactaggart sustained scratches/lacerations during the incident. Mr. Mactaggart was asked if he needed medical attention at this time which he refused.

Maywood Police department transported the victim / registered owner, Mr. Cesar Ventra to the scene (233 Industrial Ave. Teterboro NJ, 07608). Mr. Ventra took possession of his Acura white in color bearing (NJ Reg: Z94HWR) on scene and confirmed nothing was stolen from his vehicle.

Sgt. Donatello #42 from the Maywood Police Department took custody of Mr. Mactaggart on scene.
