Good Afternoon,

On Thursday, June 13th at 1:00 pm, there will be a hearing on **S2633, the "New Jersey Elections Security Act" sponsored by Senators Beach and Diegnan**. The attached bill and amendment seeks to establish a demonstration program to replace electronic voting machines with a paper ballot voting system using optical scanners. Clearly, we have issue with the implementation of this legislation, particularly as we look forward to advance our technology not retrogress.

There was a hearing before the Assembly's State and Local Government Committee on May 23rd concerning the companion bill, A3991 sponsored by Assemb. Mazzeo, Jones, and Vainieri Huttel, during which Michael Harper and I testified with a few of the County Clerks. While the NJAEO was represented well by Union, Hunterdon, and Atlantic Counties at the hearing on May 23rd, we would like as many members as possible to attend the hearing in Trenton tomorrow and show a strong force in opposition to this legislation.

I am aware that this is short notice and it will pose a conflict for many of you who will be attending the Regional III Meeting in Belmar. Indeed, I was scheduled to attend the meeting in Belmar with Dale Florio and provide the Legal and Legislative Update with my co-chair Beth Thompson, but this is too significant an issue for our organization not to address on the record before our legislators. Therefore, Beth and I have decided to split up tomorrow and she will be giving the Legal and Legs Update while I testify before the Senate Committee.

If you are available tomorrow, please join the NJAEO as we place our opposition to S2633 on the record. The hearing will take place before the **Senate State Government, Wagering, Tourism & Historic Preservation Committee at 1:00 PM. Committee Room 7, 2nd Floor, State House Annex, Trenton, NJ.**
