By certification or on oath, the complainant says that to the best of his/her knowledge, information and belief the named defendant on or about 11/23/2019 in Lacey Township, Ocean County, NJ did:

WITHIN THE JURISDICTION OF THIS COURT, PURPOSELY PREVENT A LAW ENFORCEMENT OFFICER FROM AFFECTING A LAWFUL ARREST, SPECIFICALLY BY FAILING TO ADHERE TO COMMANDS THAT HE WAS UNDER ARREST AND RESISTING THE SUBSEQUENT LAWFUL ARREST BY FLAILING HIS ARMS, TENSING HIS FISTS, STRIKING OFFICERS, AND WRESTLING WITH THREE OFFICERS AS HE IGNORED COMMANDS TO "STOP RESISTING" AT WAL-MART (580 ROUTE 9),

WITHIN THE JURISDICTION OF THIS COURT, COMMIT AGGRAVATED ASSAULT BY ATTEMPTING TO CAUSE BODILY INJURY TO PATROLMAN ANTHONY SARNO #96 OF THE LACEY TOWNSHIP POLICE DEPARTMENT, A LAW ENFORCEMENT OFFICER, ACTING IN THE PERFORMANCE OF HIS DUTIES, WHILE IN UNIFORM OR WHILE EXHIBITING EVIDENCE OF HIS AUTHORITY, SPECIFICALLY BY STRIKING OFFICER SARNO IN THE FACE DURING THE COURSE OF A LAWFUL ARREST IN WAL-MART (580 ROUTE 9) CAUSING A SMALL ABRASION ON HIS FOREHEAD,
