AT SECTION 145 – 6, “ENUMERATION OF FEES RELATING TO CODE CHAPTERS”

BE IT ORDAINED by the Village Council of the Village of Ridgewood:

Section 1: Chapter 145-6, Subsection 269, Water, of the Code of the Village of Ridgewood is hereby amended as follows:

269-34, For all meters, regardless of size, for water consumed during 1 calendar quarter, per 1000 gallons	\$4.82
269-36.1, Water service connections	
269-36.1B, New water service connection	Actual cost of service plus 20%, plus \$3575 per service unit
269-36.1C, For reconstruction	At cost, plus 20%

Section 2: Except as herein amended and supplemented, Chapter 145, of The Code of the Village of Ridgewood remains in full force and effect.

Section 3: This ordinance shall take effect immediately upon passage and publication as required by law.

Section 1: Chapter 145-6, Subsection 269, Water , of the Code of the Village of Ridgewood is hereby amended as follows:

269-34	Rates and charges for metered service
	Minimum service charge by meter size during 1 calendar quarter:
	Meters 5/8 x 3/4 inches \$32.98
	Meters 3/4 x 3/4 inches \$49.47
	Meters 1 x 1 1/4 inches \$82.44
	Meters 1 1/2 inches and less than 2 inches \$164.88
	Meters 2 inches and less than 3 inches \$263.82
	Meters 3 inches and less than 4 inches \$494.65
	Meters 4 inches \$824.42

Section 2: Except as herein amended and supplemented, Chapter 145, of The Code of the Village of Ridgewood remains in full force and effect.

Section 3: This ordinance shall take effect immediately upon passage and publication as required by law.

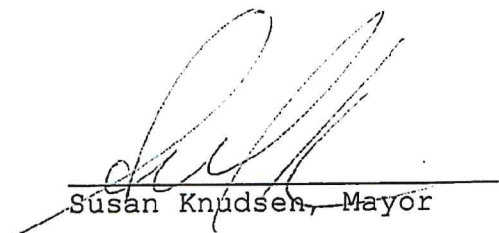

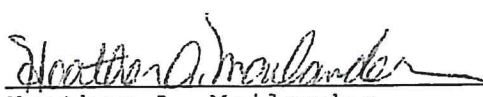

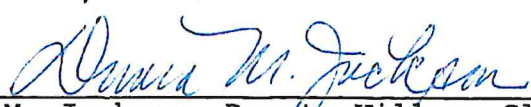
