Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

The victim and defendant met through the online service Tinder. They never met in person and their initial conversations did not materialize into anything as the victim was not interested in the defendant.

The defendant contacted the victim multiple times on the phone and social media harassing her. He used various social media to platforms to contact her, sometimes using a false identity.

On 5/9/19, the defendant contacted the victim on Snapchat and inquired if her mother was home, the victim asked why and the defendant stated I am coming over, the victim replied "to get arrested" and the defendant replied "to fuck." He then sent an image of a penis to her. When the victim asked if he knew where she lived he replied "Neptune" and sent a Google Maps image of her home and stated "728 Wayside Road your bedroom is on the first door on the left. oops lma." All of which is accurate. He also sent a previous Snapchat photo to the victims mother that the victim had earlier posted. When he sent it to the victims mother he stated "your daughter is selling her body and I love it." The defendant and the victims mother have never met and it is unknown how he obtained her cellular phone number.

On 6/15/19, D.M. reported an active burglary to her residence in which her bathing suit top and bra were removed from her bedroom after it was entered via an unlocked window at 3:00 a.m. after removing the screen and pushing up the window. The victim was asleep on the living room couch when the Burglary was occurring. The defendant was found a short time later in the area with said bathing suit top and bra. He was charged with Burglary, Theft and Criminal Mischief.

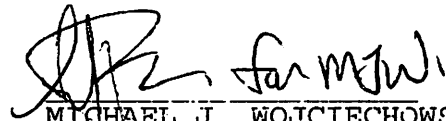

DEFENDANT IS TO OBTAIN A PSYCHIATRIST EVALUATION AND TREATMENT AND MUST COMPLY WITH ALL RECOMMENDATIONS CONTAINED IN TASC EVALUATION AND DR. SILVERMAN REPORT. DEFENDANT MUST COMPLY WITH STALKING RESTRAINING ORDER CONDITIONS AS TO ALL FOUR (4) VICTIMS FILED ON MAY 21, 2020 PURSUANT TO N.J.S.A. 2C:12-10.1

ALL FINES ARE PAYABLE THROUGH PROBATION IN EQUAL INSTALLMENT THE PERIOD OF PROBATION.
