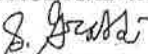
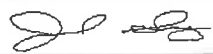
Vehicle #1 was backing northbound out of a parking space in the rear lot of 242 Kings Highway East. Vehicle #2 was parked legally and unoccupied facing west. As Vehicle #1 was backing impact occurred. The rear passenger side bumper of Vehicle #1 struck the rear driver side bumper of Vehicle #2.

Vehicle #1 sustained minor damage to the rear bumper. Vehicle #2 sustained minor damage to the rear bumper. Vehicle #1 was left on scene and Vehicle #2 was driven from the scene.

The owner of Vehicle #2 relayed to me that she was returning to her vehicle when she observed Vehicle #1 reverse and strike her parked vehicle. Driver #1 was observed to be driving under the influence and placed under arrest. Refer to Officer Donnelly's Drinking and Driving Report.

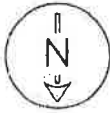

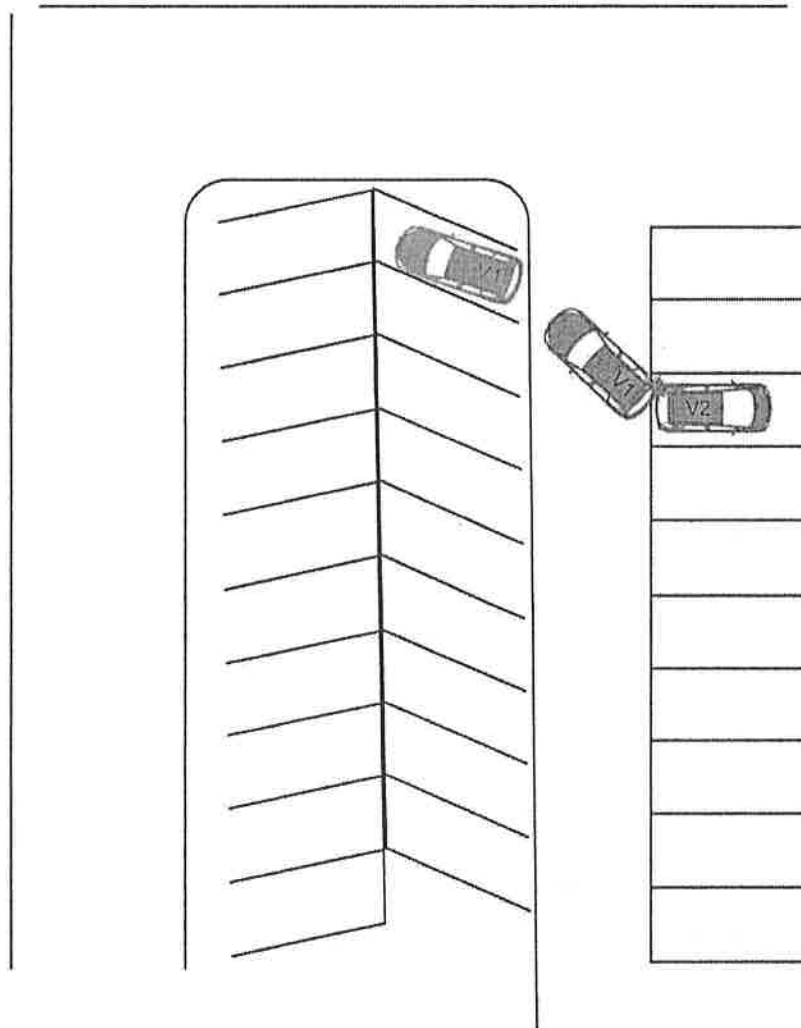

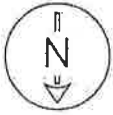

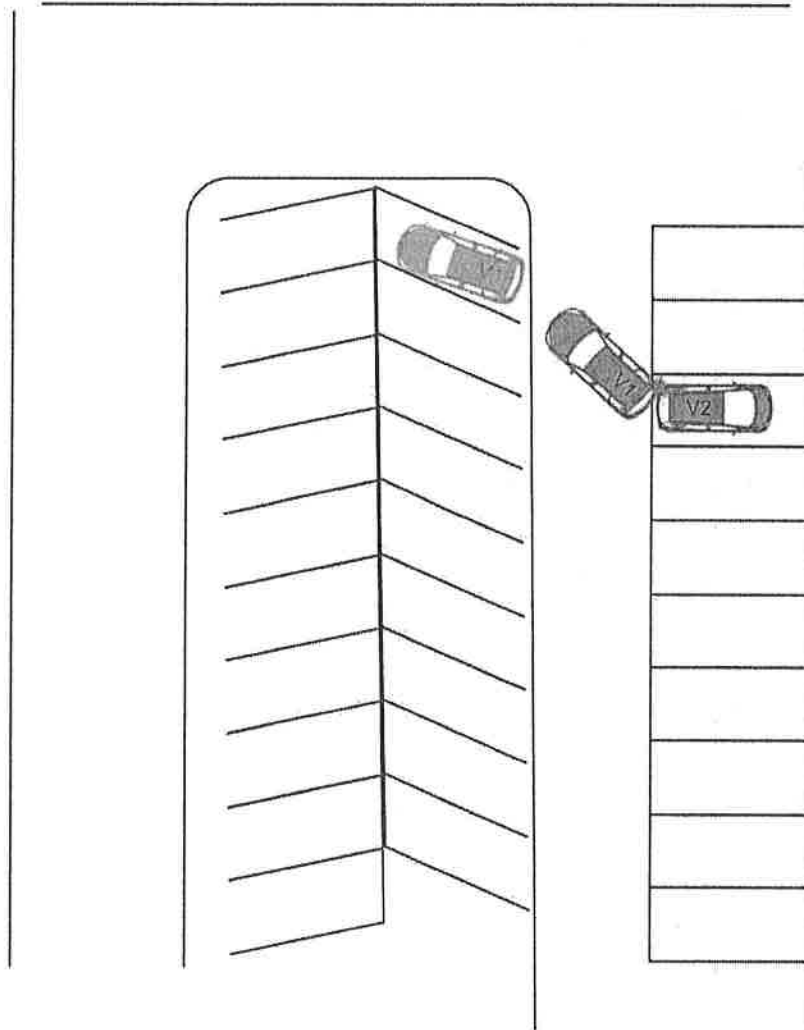

N.J. ATTORNEY GENERAL'S STANDARD STATEMENT
FOR MOTOR VEHICLE OPERATORS (N.J.S.A. 39:4-50.2(e))
(revised & effective July 1, 2012)

Enter Defendant's Name William D. Walsh

The police officer shall read the following:

1. You have been arrested for driving while intoxicated. N.J.S.A. 39:4-50.
2. The law requires you to submit samples of your breath for the purpose of testing to determine alcohol content.
3. A record of the taking of the breath samples, including the test results, will be made. Upon your request, a copy of that record will be made available to you.
4. After you have provided samples of your breath for testing, you have the right, at your own expense, to have a person or physician of your own selection take independent samples of your breath, blood or urine for independent testing.
5. If you refuse to provide samples of your breath, you will be issued a separate summons for the refusal. A court may find you guilty of both refusal and driving while intoxicated.
6. If a court finds you guilty of the refusal, you will be subject to various penalties, including license revocation of up to 20 years, a fine of up to \$2000, installation of an ignition interlock, and referral to an Intoxicated Driver Resource Center. These penalties may be in addition to penalties imposed by the court for any other offense of which you are found guilty.
7. You have no legal right to have an attorney, physician or anyone else present for the purpose of taking the breath samples. You have no legal right to refuse to give, or delay giving, samples of your breath.
8. Any response from you that is ambiguous or conditional, in any respect, to my request that you provide breath samples, will be treated as a refusal to submit to breath testing. Even if you agree to take the test, but then do not follow my instructions, do not properly perform the test, or do not provide sufficient breath samples, I will charge you with refusal to submit to breath testing.
9. I repeat, the law requires you to submit samples of your breath for testing. Will you submit the samples of your breath?

If the arrested person does not respond, or gives any ambiguous or conditional answer short of an unequivocal "yes," the police officer shall read the following.

Your answer is not acceptable. The law requires that you submit samples of your breath for breath testing. If you do not answer, or answer with anything other than "yes," I will charge you with refusal. Now, I ask you again, will you submit to breath testing?

1. OPERATION OF THE MOTOR VEHICLE:

On May 30th. 2024, at approximately 1851 hours, units were dispatched to the rear lot of borough hall, (242 Kings Highway East) for a two vehicle crash. Upon arrival, Ptl. Grassi made contact with the owner of vehicle 2. The owner of vehicle 2, stated she witnessed vehicle 1 backup from a parking spot and strike her parked vehicle. (Refer to Ptl. Grassi's accident report for details of the crash)

ARRIVAL ON SCENE:

Upon arrival, Ptl. Grassi advised me that the striking vehicle is being parked several parking spots away. He advised the striking vehicle involved is a [REDACTED] bearing [REDACTED]. Prior to contacting the driver, I checked the rear-end of [REDACTED]. I observed scratches and scrapes on the rear passenger side of the vehicle. As I approached the driver's side of the vehicle, the driver/defendant stepped out of the vehicle. I then requested his driver's license, registration, and proof of insurance. The defendant immediately provided his registration and insurance card. I asked the defendant what happened as he was flipping through his wallet for his license. The defendant mentioned he was not exactly sure what happened during the accident. As the defendant spoke, I could smell the odor of an alcoholic beverage emanating from his breath. I also noticed the defendant's hand movements were slow and fumbling as he was looking for his license. I asked the defendant if he consumed any alcoholic beverages today, at which time he said, "yes". I asked how many and he stated 2-3 alcoholic beverages. When I asked where he consumed said beverages, he mumbled incoherently an unknown location. At this time, Sgt. Sorg arrived on location. I briefly stepped away from the defendant to speak with Sgt. Sorg about my findings. When I re-approached the defendant, I observed him leaning his back on the car for support. Based on my observations and the defendant's admittance of alcohol consumption, I requested the defendant to perform a series of field sobriety tests.

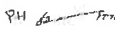
The area where the tests were performed were free and clear of debris. The surface was also flat and level. The weather at that time was clear and sunny.

The first test I had the defendant perform was the Horizontal Gaze Nystagmus test. I asked the defendant if he had any issues with eyesight that could prevent him from completing this test. The defendant stated, "no". I asked the defendant to stand with both feet together and place his hands by his side, which he did. I then took out my silver pen with a black tip and placed it 12"-15" in front of his eyes and asked him if he could see the tip of my pen, he advised that he could see it. I proceeded to check both pupils for equal size and equal tracking in both eyes. Both of the defendant's eyes appeared to be normal. There was also no resting nystagmus observed. As a result of the test, I noticed a lack of smooth pursuit in both eyes, distinct and sustained nystagmus at maximum deviation in both eyes, and the onset of nystagmus prior to 45 degrees in both eyes. I also noticed the defendant was swaying as he performed this test.

For the next tests, I had the defendant take several steps forward so we could utilize the yellow parking lines. This area was also flat, level, and clear of debris. As the defendant walked to this new area, I observed him stumble. I also observed the vomit debris on the back side of the defendant's pant legs. I also noticed a large amount of vomit on the driver side running board of the defendant's vehicle.

The next test I had the defendant perform was the Walk and Turn test. The defendant was then asked to stand with both feet together with his hands at his side, as I demonstrated and explained the test. Once I was finished explaining and demonstrating the test, I asked him if he understood the test, he stated that he understood. During this test, the defendant had difficulty walking in a straight line, he stepped off the line several times. There were also 2"- 3" gaps between his toe and heel for several steps. The defendant also raised his hands more than 6 inches from his body for balance.

Following the Walk and Turn test, was the One Leg Stand test. For this test, I had the defendant stand in the starting position, which was having both feet together and having his hands placed by his side. I then demonstrated and explained the test to him. I asked the defendant if he understood the test, which he replied, "yes". I advised the defendant that he may begin when he feels ready. The defendant lifted his left knee in the air first. He was reminded to keep his leg straight. The defendant then straightened his leg out but lost his balance. The defendant placed his foot on the ground several times during the test. He was reminded to count out loud, at which time he counted very quickly before placing his foot back down. The defendant was also observed lifting his hands and arms up for balance during the test.

(37) NARRATIVE OF INVESTIGATION (Continued)

Based on the defendant's performance during the field sobriety tests and other physical indicators, I place the defendant under arrest for driving while intoxicated. Due to the incident being in the back parking lot of the Police headquarters, the defendant was not placed in handcuffs. The defendant was escorted to our rear door, where he was searched by Ptl. Grassl. Once he was searched, he was escorted inside our police headquarters. The defendant was then secured onto our bench.

AT STATION:

Ptl. Grassl began the 20-minute observation period with the defendant. During that time, Ptl. Grassl read the AG's standard statement and Miranda rights. The defendant refused to submit breath samples and invoked his Miranda rights. The refusal for breath samples terminated the 20-minute observation period.

While the defendant was being processed, I retrieved the defendant's NJ Drivers License from his wallet and observed a Voorhees Departmental Police Identification card. At this time, I notified Sgt. Sorg of my findings.

Due to the defendant's occupation status, several mandatory notifications were required. All notifications were handled by Sgt. Sorg while the defendant was being processed. Notification was made to Voorhees Police Department Officer in Charge, Sergeant Bordi at 1923 hours. Sgt. Bordi advised contact was made to his supervisor and they would be responding to the Haddonfield Police Department.

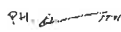
