On May 27, 2019, Willis Paulino was involved in a motor vehicle crash on Route 36 in Union Beach in which he rear-ended another vehicle. Paulino failed field sobriety tests and was determined to have a BAC of .17%. That night, Union Beach Police charged him with DWI. The two individuals in the vehicle he rear-ended (C.G. and H.N.) were taken to the hospital. Interviews with C.G. and H.N. and a review of their medical records revealed that they were both injured during the crash. C.G. suffered knee and back pain; H.N. had pain in her head and suffered a neck sprain.

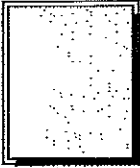

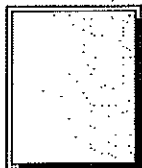
